TEMPORARY CHANGES TO THE PHYSICAL CUSTODY SCHEDULE

From time to time you may want or need to rearrange the physical custody schedule due to your work schedule, family events or other opportunities for your child(ren). It is best if you can work out any requests to temporarily change the physical custody schedule.

The person requesting the change shall do so in person by email by text by mail by telephone no later than 12 hours 24 hours 1 week before the requested change.

The person receiving the request for change shall respond in person by email by text by mail by telephone no later than 12 hours 24 hours 1 week after receiving the request.

COMMUNICATION WITH THE CHILD(REN) BY THE PERSON WHO DOES NOT HAVE PHYSICAL CUSTODY

- Each parent, grandparent or other party who does not have physical custody of the child(ren) may contact the child(ren) once a day, every other day other _____, at a reasonable time and for a reasonable duration so as not to interfere with the other parent's, grandparent's or other party's period of physical custody.

DISPUTES THAT MAY ARISE UNDER THE PARENTING PLAN

- We will attempt to resolve any disputes that may arise in our parenting of the child(ren) between ourselves.
- If we cannot resolve any disputes that may arise, we will use mediation. Mediation is available through the Dauphin County Bar Association (232-7536) or through the Neighborhood Dispute Center (233-8255).
- We recognize that it is in the best interest of the child(ren) if we can solve any problems in the parenting of the child(ren) without court intervention.
- If we cannot solve any parenting issues by ourselves, we will pursue co-parenting counseling.
