X. ITEMS FOR DISCUSSION

- A. Consideration of proposals from Zelenkofske Axelrod, LLC to extend their audit services to Dauphin County for 2004, 2005 and 2006 for the following audits:
 - 1. General audit of Dauphin County's financial statements; 2004 = \$156,045. This figure represents a 3% increase from the 2003 cost. Our cost would increase by 3% in 2005 and 3% in 2006. Thie proposal also calls for ZA to perform the 911 audit at the cost of \$5,565 in 2004 and to increase by 3% in both 2005 and 2006.
 - 2. Audit of Dauphin County tax collectors to be performed on a cycle basis (10 per year) for an annual fee of \$39,315 in 2004 (a 3% increase from the 2003 fee). The proposal calls for a 3% increase in 2005 and a 3% increase in 2006.
 - 3. Audit of Dauphin County District Justices at cost of \$35,020 in 2004; this represents a 3% increase over the 2003 cost. The proposal calls for a 3% increase in 2005 and a 3% increase in 2006.
