## **APPROVAL OF MINUTES**

Mr. Haste: We have the January 19, 2005 Workshop Meeting, January 19, 2005 Salary Board Meeting, January 26, 2005 Legislative Meeting and the January 26, 2005 Salary Board Meeting minutes. Is there a motion to approve these four minutes?

Mr. Hartwick made the motion to approve January 19, 2005 Workshop Meeting, January 19, 2005 Salary Board Meeting, January 26, 2005 Legislative Meeting and the January 26, 2005 Salary Board Meeting minutes. Mr. DiFrancesco seconded the motion. All were in favor. Motion carried.

# **DEPARTMENT DIRECTORS/GUESTS**

- A. Andrew Giorgione, Esq.
  - 1. Approval of a revised Stipulation Settlement between Pennsylvania Waste Industries Association, Republic Services of Pennsylvania, LLC and Penn Waste, Inc; and Dauphin County (Solid Waste).

Mr. Giorgione: I am back again to quickly talk about the settlement that we reached in the Pennsylvania Waste Industries Association appeal of the County's plan. These are consolidated appeals of the 2003 revision of the plan and the 2004 plan. I was before you on December 22, 2004 and you approved a settlement that date and we have had difficulties implementing signatures in that settlement. DEP didn't want to sign it. I can't really articulate why because I really do not understand their position. They said that they felt that they didn't have any role to play in this settlement. They did not have any action items to take so they did not want to sign it. We went back to the appellants and worked through the issue. Their biggest concern was if there was a breach in the settlement if DEP was not a signatory, where would jurisdiction lie for purposes of enforcement. We added a new paragraph that provides that Dauphin County Court would be the proper form to bring in enforcement action if there was a breach. Nothing

else in the settlement changed except DEP is no longer a signatory and their lines were removed from the document.

Mr. Hartwick: Isn't that unusual that they chose not to participate in the agreement?

Mr. Giorgione: I found it to be a little bizarre. When pressed on this issue back and forth, they said they just did not want to sign it. They have done that in other cases and I am not aware what cases they would be since the principal appellee is DEP. We are obviously an interested party because it involves our County plan.

Mr. Hartwick: Is that what we say to DEP when they come down on us for painting restriction or pollutions that we just do not want to get involved? I would like to find out why they chose not to be a signatory on this agreement.

Mr. Giorgione: The only substantive answer I received is that they felt that nothing was required of them by the settlement. I went over last time with you what is required of the County, which is that we proceed with our future planning consistent of what we told our appellants what we were going to do. We have a C&D based waste plan and will move forward. We agree there is a substantial plan revision and it will be implemented in the matter that we told them. DEP basically said that there is nothing for us to do here, you do your planning work and get it to us, if it is acceptable, we will approve it. No action item is required of us so we do not see any reason for us to sign it.

Mr. Haste: This is another example of the quality of leadership we have out of this Department, there is none.

# SALARY BOARD

# SOLICITOR'S REPORT—BILL TULLY, ESQ., SOLICITOR

Mr. Tully: Nothing to add to the actual Solicitor's report, but I'd be happy to answer questions.

#### MATTERS REQUIRING BOARD ACTION

Mr. Haste: Matters Requiring Board Action, we have Items A through O plus approval of the signing of the stipulation settlement Mr. Giorgione discussed today. I think it is important to bring up Item N. Item N is a resolution that our County Commissioners Association has asked us to pass. Monday in the Capitol Rotunda, there will be legislators, as well as, the County Commissioners Association, speaking about the unfairness of the current tax situation: the real estate property tax that Counties have to follow. At that point in time, CCAP will be presenting what they call their tax fairness program. They started to circulate it through the Legislature last time. They went into a new legislative session and those bills will be reintroduced and hopefully in enough time that the Legislature and the Governor will take it seriously and look at it. But particularly Jack, I hope someone is there from the Patriot. As you heard us talk in this room about how unfair and archaic the system is, I think you are going to see real clear that other Counties are in that same situation. Few weeks go by without something being reported in the media about a county and its problem. Yesterday or today there was something reported about a county going before a Judge on their millage rate. The Judge did not approve the full request that the County had submitted and how the problems that are facing that County. Hopefully someone is there and they pay attention to what is being said. It will be our responsibility, as well as, CCAP's, to keep the pressure on the Legislature for reform.

Mr. Hartwick: I completely concur with Commissioner Haste's comments. This was voted the number one issue with the Counties and CCAP. I know Commissioner Haste has been an outspoken advocate and rightfully so. I do not see the situation improving from the Federal Government side. We saw a list of proposed federal budget cuts which include Housing Development, Human Services and CDBG, which are the love brunt of communities and counties as it relates to our ability to invest in our communities

and to help those who need it the most. Ultimately we need to figure out, from the County's perspective, how we are going to deal with these issues as they come down from the Commonwealth then to the Counties for us to be able to provide the level of services with decreased funding. The tax issue is going to become more and more of an issue as these issues begin to unfold. I will be at the Capitol that day as well.

Mr. DiFrancesco: This is one of the most critical issues that we are dealing with. The first step is this resolution that we are going to pass. The second is to take action. We are at the start of a new legislative session and we see on a daily basis residents who are extremely concerned about this tax issue. Now is the right time to take this battle to Capitol Hill. This resolution is certainly a significant fact on this Board's part but probably the most important things that we can do in our term in office is to advocate and win tax reform before the state legislature. This plan calls for tax flexibility. This would give each county an opportunity to evaluate which tax base works best within that economic structure to fund the important services that Dauphin County and all of the other counties carry out. Quite honestly, you have heard it before, you have heard it from each member of this Board, the property tax that we are forced to live on right now, is a very dangerous tax, it is archaic and long over due to be changed. As we are forced to fund more and more programs without adequate revenue from the State, every time we have to make the very difficult decision to raise taxes, people lose their homes. That is a destabilizing factor in this County and Pennsylvania. It makes our communities worse not better. We need to have the opportunity to fund county government in a way that best suits the area and this resolution is the first step. I will go one step further and say that we will be very vocal on this issue and we urge the community to stand up and get involved now early on in the legislative session. Now is when we can take the battle up and give it a chance at life. As time goes by, there is less opportunity for this to pass and it needs to happen and it needs to happen now.
