MINUTES

- A. Resolution #24-2009 authorizing a temporary increase to the Affordable Housing Fund Checking Account from \$70,000 to \$100,000. (***A VOTE IS REQUESTED 10/21/09***)

Mr. Haste: We have two items on the Agenda for discussion and action. Item A deals with the purchase of the old gas station on Front Street by Fort Hunter. Item B is for the Affordable Housing. A good note on that is we have seen a tremendous increase over the last couple months. In fact, I had a phone call on this. Before I knew this was coming up, I had a conversation with Skip and Terry. It looks like we are over 30 applications.

Mr. Haines: We have 36 for October and about 26 for November already.

Mr. Haste: You normally do 15.

Mr. Haines: We normally do 12 to 15 a month.

Mr. Haste: That is a good sign to see where young families and folks are getting into homes.

Mr. Hartwick: Also the tax credit program runs out so everyone is trying to get in under the wire.

Mr. Haste: This is just to increase the amount. My understanding is that those funds come from a fee that is collected in the Recorder of Deeds Office. We will just up that amount so Terry can get these people into their homes.

It was moved by Mr. DiFrancesco and seconded by Mr. Hartwick that the Board approve Items A and B, listed above under Items for Discussion; motion carried.

<u>SOLICITOR'S REPORT – WILLIAM TULLY, ESQ.</u>
