
ORDER

AND NOW, this 5th day of April, 2012, it is hereby **ORDERED** that:

1. Counsel for Defendant Timothy Curley shall file a Reply to the Commonwealth's Combined Answer and Memorandum of Law in Opposition to Defendant's Pretrial Motion, Section II, Answer to Defendant Curley's Petition for Writ of Habeas Corpus, on or before April 17, 2012;
2. Counsel for Defendant Gary Shultz shall file a Reply to the Commonwealth's Combined Answer and Memorandum of Law in Opposition to Defendant's Pretrial Motion, Section III, Answer to Defendant Schultz's Petition for Writ of Habeas Corpus as To Count One of the Information, on or before April 27, 2012
