Any person or company that collects processes, transports, or disposes of municipal solid waste (“MSW”) or construction and demolition (“C&D”) waste generated in Dauphin County.

**Terms of Registration:**

By completing and signing the Application, the Registrant hereby understands, acknowledges, and agrees to abide by the Dauphin County Rules and Regulations, Dauphin County Waste Ordinance and provisions of the Dauphin County Municipal Solid Waste Management Plan, and furthermore to provide any and all documentation requested by the County for compliance purposes.

In consideration of the County’s Registration issuance, the Applicant agrees to indemnify and defend the County for any cost, damage, claim, liability, assessment, penalty, loss and/or expense incurred, directly or indirectly by reason of act or omissions by the undersigned Applicant, its agents and employees, including but not limited to any violation of the Dauphin County Rules and Regulations, Dauphin County Waste Ordinance, and the Dauphin County Municipal Solid Waste Management Plan, or any provision of the 2014 Waste Hauler Registration Application.

The Applicant agrees to fulfill the Waste Hauler registration requirements upon issuance of a Registration Certificate. **Waste Hauler registrations that are issued will be valid from January 1 – December 31, 2017.**
